Lost Pets Finders

Lost your pet? Found a lost pet? Here is a new FREE bulletin board.



Pet owners, you know how it is. You let your dog out and he runs off. Or your cat decides to spend a few days outdoors to "find herself." You make 25 copies of a "Lost Pet" sign, add your phone number and an old picture of your errant pet, tape them to utility poles, mailboxes, and trees, and then you wait. The next day it rains and washes the ink from your signs.

Or maybe some new dog or cat has begun hanging around your house, but you don't know how to begin to find its owner.

Well, now you can search for lost pets or lost owners online for FREE! Someone who has either lost or found a pet can upload details and a photo about that pet on a new website-www.WaterfordLakesLostPets.com. They will send emails to "Pet Patrollers" who have signed up on their email alerts distribution list. It's kind of like an animal Amber Alert. That way, as a community and as neighbors, we can look out for each other and our pets.

This new website is a clearinghouse for pet owners in Waterford Lakes, Avalon Park, and the surrounding areas of East Orlando, helping to reunite pets who have become separated from home with their owners.

Ward and Cheri Wells started Waterford Lakes Lost Pets this year, and they have about 70 people on their email list. They also operate LoveyLoaves Inc. (www.LoveyLoaves.com), a pet advocacy and wellness non-profit organization. The new pet-finder service was modeled on a similar website that has been successfully serving Winter Park for about two years.

ARC Request & Approval

As a reminder, all changes to the properties within Cypress Isles community are required to be approved by the Architectural Review Committee (ARC) prior to implementing the changes.

So how does the ARC review & approval cycle work?

1. Contact the WLCA office at the community pool cabana, call 407-380-3803 to get the proper ARC application form, or go to our website: www.cypressisles.org to download it.

DO NOT IMPLEMENT REQUESTED CHANGES PRIOR TO APPROVAL BY THE ARC.

2. Complete the top section; provide information on requested change. Listed below are examples of the information that is needed with the application is submitted.

- If submitting a structural change (fence, swing set, landscaping, pool, building addition), include a copy of the plot plan with the changes noted on plot plan.
- If requesting solar panel approval, note which sides of the roof the panels will be installed.
- If changing the color of the home, include samples of the colors and note where colors are to be used (trim, walls, porch, etc.).
- If tinting windows, include sample of material to be used.

3. Take the completed application form to WLCA. WLCA will log it in and send it to the Cypress Isles ARC. The CI ARC and WLCA have up to 30 days to approve or disapprove the request.

4. Once approved by both the Cypress Isles and WLCA ARC, a copy of the application will be mailed to the requestor. If disapproved, the ARC will provide written rationale for disapproval or ask homeowner to resubmit the application.

Architectural Review Committee

Whose Job Is It Anyway?

We live in the midst of traffic jams and bureaucratic mazes, so it's no surprise that we often don't know who can help us with which types of problems. We hope the alphabetical list below will provide some of the answers. If you know of others, please let us know so we can share.

Alligators – Florida is alligator country, and they're allowed to be here, same as you, unless they become physically threatening. If the alligator is away from you, leave it alone. Most likely the alligator will just stay where it is. If you are close to the 'gator, move away. Alligators are very fast in the water, but they can also run pretty fast on land, especially if they have the munchies. An alligator can outrun a human for short distances.

The Florida Game and Fresh Water Fish Commission (352-732-1225) will not come out until an alligator has grown to 6 feet or longer, or until it becomes aggressive toward humans.

- Animals, dead Contact Orange County for removal of dead animals in the road and sidewalk areas of Waterford Lakes. Dial 311 and report the problem and be as exact as possible as to the location.
- Animals, pets (unleashed pets, pets tied to trees in the sun without water, etc.) – Call Animal Control at 407-352-4390.
- Animals, wild For all problems with wild animals, you must hire a private nuisance trapper. Orange County Florida Animal Control will only assist in problems involving dogs and cats, but will **NOT** assist in any situation involving wild animals, such as raccoons, squirrels, and snakes.

- Crime (break-ins, burglary, lost property, theft, vandalism, vehicle burglary, etc.) - If it's happening right now, call 9-1-1 and stay on the line. If it happened before now – like you just got home and your home has been broken into – call the Orange County Sheriff's Office non-emergency number at 407-836-HELP (4357). If nobody answers, call 9-1-1. Or you can file a crime report online.
- Crime reporting on line Go to www.ocso.com and click on "E-Reporting" to report nonviolent crimes online, such as lost property, theft, vandalism, and vehicle burglary. Click on "Property Crimes and Robberies in Your Zone" to find out what types of crimes are occurring in your area. Go to www.cfcrimelinewarrants.com - to check individuals for warrants.
- Dig, but call before you do Power, phone, and cable lines are buried everywhere. Dial 8-1-1 for the Sunshine Network 811, or go to www.call811.com and soon technicians will fill your lawn with little flags.
- Disaster Plan The Waterford Lakes Disaster Plan is posted within the WLCA website. (http://www.mywaterfordlakes.org > Documents > WLCA Long Range Planning Committee > Disaster Plan.) The plan includes guidance for neighborhoods and residents.
- Neighbors with unkempt yards Contact your neighborhood association. If the problem is an Orange County Code violation, your neighborhood association should "kick it upstairs" to the county.

Neighbors, nosy – You're on your own.

Neighbors, unruly – Your neighborhood association and WLCA do <u>not</u> have jurisdiction over neighbor behavior. Call the Orange County Sheriff's Office nonemergency number at 407-836-HELP (4357), or if nobody answers, call 9-1-1. If you and your neighbor are having a dispute, call Orange County Bar Association Citizen Dispute Settlement at 407.423.5732.

- Power Outage Call Progress Energy at 1-800-228-8485, or go to www.progressenergy.com.
- Speeders Report the tag number to Orange County Sheriff's Office non-emergency number at 407-836-HELP (4357), or if nobody answers, call 9-1-1. If UCF students are speeding and you report their tag numbers (or even better, student tag numbers) to Orange County Sheriffs and ask the sheriffs to report them to UCF, the sheriffs will report them to UCF, and UCF can discipline the offending students.
- Streetlight Repair– Know the address closest to the light (light pole number is even better), then call Progress Energy at 1-800-228-8485, or go to www.progress-energy.com > Residential > Florida > Request Streetlight/Area Light Repair in Florida.
- Suspicious people Contact your neighborhood watch block captain. (See Neighborhood Watch.)

Trick-or-treaters: Watch out for vehicles and be extra careful because your costumes can make it hard to see. Carry a flashlight to make it easier for you to see, and for others to see you.

Everyone: Don't forget to check those goodies before eating them.

As the Clock Turns





Halloween seems like a long way off, but it's really just around the corner and will be here before you can say "Boo!"

Trick or Treat night will be on Monday, October 31st (a.k.a. Halloween), starting at 6 PM., ending at 9 P.M., or whenever the treats run out. Turn your porch lights on and meet your neighborhood goblins.

Where to go? I'm glad you asked. Good rule of thumb, or foot, is: Porch light on – go there. Porch light off – don't go there.



Remember last March when we sprang forward and lost that hour of sleep? Well, soon you will be able to regain that hour of lost sleep (supposedly). On Sunday, November 6 at 2 a.m. we return to EST – Eastern Standard Time. This means you will turn your clock BACK one hour. So you can either set your alarm to get up at 2 a.m. and make the change, or do it at a reasonable hour later in the morning, or before you go to bed Saturday night. No excuses for being late the next day, like when Daylight Saving Time returns in the spring. And don't forget to change those smoke alarm batteries, if applicable, and other things you may only do twice a year when the clocks change...
