# Dec 2012 Holiday Lighting Contest Winners

December 16<sup>th</sup> was a Sunday much like any other Sunday. The 1:00 football games had produced disappointing results, and disappointing results of the 4:00 games were in progress. But the weather was nice, so shortly after 7 p.m. the Three Wise Judges loaded their award signs into a pickup truck and slowly drove around the neighborhood several times, checking out decorations.

Apparently not everyone had read about the Holiday Lighting Contest in the November *Cypress Isles News*, because one angry homeowner jumped into his own pickup truck and chased down the judges, accusing them of spying on his daughters. After the judges explained that they were judging decorations, not daughters, the homeowner calmed down and the judging continued.

Some parts of Cypress Isles were entirely dark, but other parts were brilliantly decorated. After two hours of looking at decorations and comparing notes, the winners were identified. There was no money involved, rather signs placed on the lawns of these winning homes:

- **525 Divine Circle** was judged to be **Most Enchanted** with a red-bordered walkway leading to red and green floodlit columns surrounded by multicolored bushes.
- 731 Divine Circle received the White Christmas award for best all-white display.
- 806 Spring Island Way featuring bluetrimmed white icicles was awarded Most Elegant decoration.
- 849 Spring Island Way once again had the Most Animated holiday lawn decorations.
- 867 Spring Island Way was given the True Meaning of Christmas award for their simple but meaningful crèche.
- **902 Spring Island Way** was awarded **Most Joyful**, with special recognition of their bright blue peacock.
- **13768 Crystal River Drive** was awarded **Most Original** for their creative use of palms to convert their driveway into a lighted archway.
- 14024 Lake Underhill was given the Outreach Award for "Best Decorations Visible from Cypress Isles even though They Don't Actually Live Here" -- This is Betty and Joel Matthias's third year winning this prestigious award.

Honorable mention went to the homeowners on Cedarwood Court and White Cedar Court, both of which had almost every home decorated. We don't have signs for this yet.

So thanks to all who decorated and helped to make the season bright!

# **Neighbors, Trim Thy Trees**

Low-hanging branches? Take a bough. (Groan)

**Problem #1** - It's early evening and you're driving home when you hear -- whang, whang -your car antenna whanging against the low branches hanging over the street. Don't you hate that? Why don't they trim those branches? Oh wait - that's your house, that's your tree, and those are your branches.

**Problem #2** – You're out for an evening stroll but you have to bob and weave like a prizefighter to avoid getting whacked in the face by low-hanging branches over the sidewalk. But wait – that's your tree, too!

**Solutions for #1 and #2** – Tonight, instead of the evening stroll, get your loppers (or borrow them from your tool-crazy neighbor) and trim those branches. How high, you ask? Seven (7) feet over the sidewalk and twelve (12) feet over the driveway and street, we answer.

The seven-foot trim is easy. Just stand under the tree, raise the loppers over your head, grab any branch the lopper can reach, take a step back to avoid falling branch, and lop. Do this all around the tree, not just over the sidewalk, so the tree looks decent when you're finished.

The 12-foot trim over driveways and streets is a little trickier, but it's necessary to prevent that nails-on-blackboard sound of branches scraping against trucks. For this you'll need either a six (6) foot stepladder or an Adjustable-Reach Telescoping Tree Trimmer from your tool-crazy neighbor. Just be careful not to accidentally bash in the windows of parked or passing cars with the bottom of telescoping trimmer while you're looking up into the tree. Hate when that happens, too.

Finally, gather all the fallen branches, cut them into 4-foot lengths, bundle them up, and kick them to the curb by early Wednesday morning for yard-waste pickup. And we do mean early.

That's about all the tree-mendous advice we have for now. (Closing groan)
